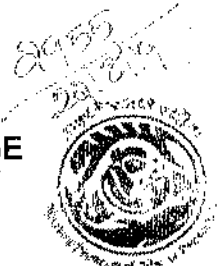

In compliance of the amendment, the Regional Office of MOEF&CC, Bengaluru has decided to receive the Half Yearly Compliance Reports (HYCRs) only in soft copy. This office has communicated the decision to all projects proponents granted with Environmental Clearance by MOEF&CC, New Delhi and also are in the process of causing an advertisement in leading newspapers of various states.

The regional office of MOEF&CC, has created a dedicated email ID for exclusive use in the receipt of communications related to the Environmental section. We hereby request your office to forward all further communications related to the grant of EC and its related matters to the following email ID only: rosz.bng-mefcc@gov.in You are also required to make necessary changes in the conditions of Environmental Clearance issued by SEIAA and clearly mention that submission of Half Yearly Compliance Report is to be made to the Regional office by email only at the above given email ID. State Pollution Control Boards are also requested to take note of the amendment and accept soft copies of reports. The submission of Half Yearly Compliance Report as stipulated under the conditions of EC may please be specified as follows:

"The HYCRs with its contents of a covering letter, compliance report, and environmental monitoring data has to be in PDF format merged into a single document. The email should clearly mention the name of the project, EC No & date, period of submission and be sent to the Regional Office of

MOEF&CC by email only at email ID rosz.bng-mefcc@gov.in Hard copy of HYCRs shall not be acceptable."

This is also to draw your attention to the despatch of all documents related to the grant of Environmental Clearances under the administrative control of your office. Care may please taken to duly attach copies of EC's to this office and also send a database of all ECs issued in a calendar year for up-dation of this office database.
