ORDER

Environment Clearance had been accorded to Shri. Manoj Nair, CEO, M/s Smart City (Kochi) Infrastructure Pvt. Ltd., Smart City Pavilion, Bhrahmapuram P.O., Ernakulam, Kerala - 682303, for the expansion of the existing Master Plan Development of an IT/ITES SEZ township project of M/S Smart City (Kochi) Infrastructure Pvt. Ltd. at Sy. Nos. 640/1, 640/2 & others in Kakkanad village, Sy. Nos. 62/1, 62/2 & others in Puthencruz Village for a period of 5 years as per the proceedings read as 1st paper above.

2. As per paper 2nd above, request was received from Project Proponent for changing the validity period mentioned in the EC issued *ie.*, from 5 years to 7 years, as per the EIA Notification, 2006.
3. Vide paper 3rd above the proposal was placed in the 113th meeting of the SEIAA Kerala, held on 19th & 20th April 2022. The Authority verified the proposal and the request of the Proponent for extension of the validity period, agreed with the request of the proponent as he is eligible for the same as per EIA Notification 2006.
4. In this circumstance, the validity of Environmental Clearance for the expansion of the existing Master Plan Development of an IT/ITES SEZ Township project of M/S Smart City (Kochi) Infrastructure Pvt. Ltd. at Sy. Nos. 640/1, 640/2 & others in Kakkanad village, Sy. Nos. 62/1, 62/2 & others in Puthencruz Village owned by M/s Smart City (Kochi) Infrastructure Pvt. Ltd issued as per proceedings read 1st above is extended from 5 years to 7 years subject to the strict compliance of the conditions in the EC/Extension of EC already issued. The Project proponent shall ensure that no violation of EC conditions takes place during the extended period of EC.
5. The Half Yearly Compliance Report (HYCRs) with its contents, covering letter, compliance report and environmental monitoring data has to be uploaded in the PARIVESH portal & the website of the proponent. Hardcopy of HYCRs shall not be acceptable.
