SEIAA Kerala - Removal of ordinary earth in Sy. No. 497/5 at Ezhamkulam Village, Adoor Sub: Taluk, Pathanamthitta District, Kerala by Sri. K. Sadanandan - Environmental Clearance under EIA Notification 2006 accorded - Orders issued

ORDER

Mr. K. Sadanandan, Ampadiyil New Bungalow, Pannivizha, Adoo P.O. KPathanafuthitta District, Kerala, has applied for Environmental Clearance on 11.02.2014 in simplified format for removal of 877 m³ of ordinary earth from 0.74.66 hectares of land in Sy. No. 497/5 of Ezhamkulam Village, Adoor Taluk, Pathanamthitta District, Kerala, for levelling the plot. The application has been duly examined and forwarded by District Collector, Pathanamthitta. The removed earth shall be utilized for dumping in own plot bearing Sy. Nos. 327/2 & 326/9 of Ezhamkulam village and for levelling the play ground of College of Sree Narayana Institute of Technology. Forest land is not involved in the project. It is interalia, noted that the project comes under Category B, Activity 1(a), (i) of Schedule of EIA Notification 2006.

The proposal has been appraised by the State Level Expert Appraisal Committee Kerala constituted by the competent authority, as per prescribed procedure in the lights of provisions under the EIA Notification 2006 and subsequent amendments, in its 26th SEAC meeting held on 20th and 21st March 2014. SEAC Kerala considering the application, documents and clarifications provided by the proponent in person, recommended environmental clearance to the project.

The SEIA after due consideration of the relevant documents and additional clarifications submitted by the project proponent, and in view of the recommendations of SEAC, approved for issuance of Environmental Clearance for the project mentioned above at its 29th SEIAA meeting held on 09-04-2014. Accordingly, the State Level Environment Impact Assessment Authority (SEIAA) Kerala constituted by Govt. of India vide Notification No. S.O. 24-84(E) dt. 3-11-2011 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 2074 on 3-11-201 1 and

further amended by Govt. of India vide Notification No. \$0.546(E) dt.25.02.2014 of Ministry of avironment and Forests, Govt. of India, published as Gazette extraordinary No. 466 dated 25-02-2014, hereby accord necessary Environmental Clearance to Mr. K. Sadanandan, Ampadiyil New Bung alow, Pannivizha, Adoor P.O., Pathanarmthitta District, Kerala, for removal of 877 m³ of ordinary earth from 0.74.66 hectares of land in Sy. No. 497/5 of Ezharmkulam Village, Adoor Taluk, Pathanamthitta District, Kerala, as per powers vested with it under the provisions of Environment Impact Assessment Notification - 2006 and subsequent amendments and also under the provisions made in O.M. No. L-11011/47/2011-IA.II(M) dated 18th May 2012 of the Ministry of Environment and Forests, Government of India, and further subject to strict compliance of the following specific conditions:

- (i) The activity shall not involve blasting.
- (ii) The maximum depth of removal of earth should not go beyond 2 m from the general ground level of the site, which should be prominently marked before initiating the work.
- (iii) Removal of earth should be restricted to 2 m above to the ground water table at the site.
- (iv) The excavation activity shall not alter the natural drainage pattern of the area.
- (v) The borrowed/excavated pit shall be restored by the project proponent for useful purpose(s) as specified in the application.
- (vi) Appropriate fencing all around the borrowed/excavated pit shall be made to prevent any mishap.
- (vii) Measures shall be taken to prevent dust emission by covering of borrowed/excavated earth during transportation.
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors in the water bodies created due to borrowing/excavation of earth.
- (ix) Workers / labourers shall be provided with facilities for drinking water and sanitation.
- (x) A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
- (xi) A minimum distance of 15 m from any civil structure shall be kept from the periphery of the excavation area.
- (xii) The Environmental Clearance shall be liable to be cancelled in any case of violation of above guidelines.

Compliance of the above conditions will be monitored by the Directorate of the Department of Environment and Climate Change, Government of Kerala or its agencies and also by the Regional Office of the Ministry of Environment and Forests, Government of India located at Bangalore Recessary support for entry and inspection should be provided by the project proponent to the staff of the Directorate and Ministry for monitoring purposes. In case of non-compliance of conditions, no ted if any, the Director, Department of

Invironment and Climate Change shall report the matter to the District Collector concerned to take necessary of ion under Environment Protection Act 1986.
