## ORDER

Smt. Sainaba R., R.R. Manzil, Aathikkattukulangara, Palamel Alappuzha - 690504, has applied for Environmental Clearance on 04.01.2014 in simplified format for removal of 3036 m<sup>3</sup> ordinary earth from 20.23 Are of land in Sy. No. 590/1-2 of Palamel Village, Mavelikkara Taluk, Alappuzha District, Kerala, for construction of house. The removed earth shall be utilized by Sri.K.M.Thomas for stocking and selling. Forest land is not involved in the project. It is interalia, noted that the project comes under Category B, Activity 1(a), (i) of Schedule of EIA Notification 2006.

The proposal has been appraised by the State Level Expert Appraisal Committee Kerala constituted by the competent authority, as per prescribed procedure in the lights of provisions under the EIA Notification 2006 and subsequent amendments, in its 23rd SEAC meeting held on 6th and 7th January 2014 and 29th meeting held on 2nd and 3rd May 2014. SEAC Kerala considering the application, documents and clarifications provided by the proponent in person, recommended environmental

No. 590/1-2 of Palamel Village, Mavelikkara Taluk, Alappuzha District, Kerala, as Sainaba R., R.R. Manzil, per powers vested with it under the provisions of Environment Impact Assessment Notification - 2006 and subsequent amendments and also under the provisions made in O.M. No. L-11011/47/2011-IA.II(M) dated 18th May 2012 of the Ministry of Environment and Forests, Government of India, and further subject to strict compliance of the following specific and General conditions:

- The activity shall not involve blasting.
- The maximum depth of removal of earth should not go beyond 2 m from the general ground (ii) level of the site, which should be prominently marked before initiating the work. (iii)
- Removal of earth should be restricted to 2 m above to the ground water table at the site. (iv)
- The excavation activity shall not alter the natural drainage pattern of the area. (v)
- The burrowed/excavated pit shall be restored by the project proponent for useful purpose(s) as specified in the application.
- Appropriate fencing all around the borrowed/excavated pit shall be made to prevent any mishap. (vi)
- (vii) Measures shall be taken to prevent dust emission by covering of burrowed/excavated earth during
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors in the water (ix)
- Workers / labourers shall be provided with facilities for drinking water and sanitation.  $(\mathbf{x})$
- A berm shall be left from the buundary of adjoining field having a width equal to at least half the depth of proposed excavation. (xi)
- A minimum distance of 15 m from any civil structure shall be kept from the periphery of the
- (xii) The quantity of earth removed should not exceed 1000 m<sup>3</sup>.
- (xiii) The Environmental Clearance shall be liable to be cancelled in any case of violation of above

Compliance of the above conditions will be monitored by the Director ate of the Department of nvironment and Climate Change, Government of Kerala or its agencies and also by the Regional

fice of the Ministry of Environment and Forests, Government of India located at Bangalore. Necessary support for entry and inspection should be provided by the project proponent to the staff of the Directorate and Ministry for monitoring purposes. In case of non-compliance of conditions, noted, if any, the Director, Department of Environment and Climate Change shall report the matter to the District Collector concerned to take necessary action under Environment Protection Act 1986.
