ENVIRONMENTAL CLEARANCE NO. 66/OE/2020

Sri. Jose K. I. Kuppathadathil, Pankode P.O, Ernakulam has submitted an application for the Environmental Clearance in SEIAA for mining of Ordinary earth from the land at Sy No.203/3-2, Block No. 44 at Ikkaranad North Village, Kunnathunad Taluk, Ernakulam District, Ernakulam-682 311. The proposed quantity of the earth to be removed is 10000 m³ from an area of 0.2450 Ha. of Ordinary earth for Commercial purpose.

2. The proposal was placed in the 102nd meeting of SEAC held on 26th & 27th August 2019. The Committee directed the proponent to submit the following documents:

1. Approved Mining plan
2. Photographs of the site
3. Demand letter of the excavated earth from the proposed user

3. The proposal was placed in the 103rd meeting of SEAC held on 17th & 18th September 2019. The Committee directed the proponent to submit the approved mining plan. The proponent submitted the approved mining plan on 26-05-2020.

4. The proposal was placed in 111th meeting of SEAC held on 02nd, 03rd & 04th June 2020. The Committee decided to recommend the issuance of EC subject to the general conditions.

5. The proposal was placed in the 104th meeting of SEIAA held on 22nd, 23rd & 24th June 2020. Authority decided to issue EC for 6 months from the date of issue of permit from the Department of Mining & Geology, for a quantity of 10000 m³ of ordinary earth subject to the following specific conditions in addition to general conditions.

- 1. The proponent shall carry out quarrying as per the approved Mining Plan and the proponent should strictly follow the Kerala Minor Mineral Concession Rules 2015 and amendments thereby.*
- 2. The excavated soil shall not be used for filling the paddy fields and wetlands.*
- 3. Activities relating to Corporate Environmental Responsibility for an amount to be fixed later shall be carried out leading to protection and promotion of environment including waste management in the project district as per OM F.No.22-65/2017-IA-III dt.01.05.2018 of MoEF & CC as directed by Director, Directorate of Environment & Climate Change and supervised by District Collector.*
- 4. As per the directions contained in the OM F.No.22-34/ 2018-IA.III dated 16th January 2020 issued by MoEF & CC, in obedience to the directions of the Honourable Supreme Court the Project Proponent shall, undertake re-grassing the mining area and any other area which may have been disturbed due to his mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc. The compliance of this direction shall be*

7. Violation of any of the conditions as applicable to the particular case will entail cancellation of the Extension of Environmental Clearance, in addition to legal action under the provisions of the Environment (Protection) Act, 1986. Non-compliance, if any shall be reported to the District Collector, Ernakulam by the State Environment Impact assessment Authority
