ORDER

Sri.Saji.K.Elias., Managing Director, M/s Mariyem Granites Pvt. Ltd.. Kuzhikandathil House, Thiruvaniyoor P O, Ernakulam – 682308, submitted an application read paper 1st above, for Environmental Clearance for the Granite Building Stone Quarry project for an area of 1.5899 Ha at Block No. 41, Re-Survey Nos. 303/2-1 and 303/2-2 in Thiruvaniyoor Village, Kunnathunad Taluk, Ernakulam

- 2. In the 159th SEAC meeting, the committee noted that the SEIAA in its 124th meeting, decided to take action against the violation of conditions of EC issued vide No.SIA/KL/MIN/262617/2022; 553/SEIAA/EC/4087/2014. Since the proposed area for mining is in continuation to the project under violation, the Authority also decided to keep the proposal in abeyance till the violation procedures initiated against the Project Proponent have been completed. As per the decision of SEIAA, the committee decided to recommend delisting of the application.
- 3. The Authority, vide 5th paper read above, deliberated the item and noted the decisions of various SEAC/SEIAA meetings, including the decision in its 159th meeting and

observed that stop memo was issued on 25.01.2023 for the EC issued to the Project Proponent vide EC No. 43/2018 dated 04.07.2018 by DEIAA Ernakulam, for the violation and non-compliance of the EC conditions. Hence, the Authority decided to reject the application, and intimate the Project Proponent to submit fresh application after the completion of the violation procedures initiated against the Project Proponent.

4. In the above circumstances, the application for Environmental Clearance read as 1st paper above, submitted by Sri.Saji K.Elias, Managing Director, M/s Mariyem Granites Pvt. Ltd., Kuzhikandathil House, Thiruvaniyoor P O, Ernakulam for the Granite Building Stone for an area of 1.5899 Ha at Block No. 41, Re-Survey Nos. 303/2-1 and 303/2-2 in Thiruvaniyoor Village, Kunnathunad Taluk, Ernakulam is hereby REJECTED, for the reasons mentioned in Para (2&3) above. The concerned department shall take necessary actions, if any. The Project Proponent has the liberty to submit a fresh application once the violation procedures initiated is completed.
