Sri. Nasser T.M. & Noushad T.M. Thekkilakudy House, Vengola P.O, Perumbavoor, Ernakulam -683556 has submitted an application for the Extension of Environmental Clearance in SEIAA for mining of Ordinary earth from the land at Re-

Survey Nos. 158/3, 158/4-2 of Arackappady Village, Kunnathunadu Taluk, Ernakulam District. The proposed quantity of the earth to be removed is 8500 m<sup>3</sup> from an area of 0.4179 Ha of Ordinary earth for Commercial purpose.

- 2. The proposal was placed in the 104<sup>th</sup> meeting of SEAC held on 10<sup>th</sup> & 11<sup>th</sup>October 2019. The Committee directed the proponent to submit the following documents:
  - 1. Mining plan approved by the competent authority.
  - 2. Depth of mining.
  - 3. Details or Evidence of certificate for endues of excavated earth.
  - 4. Ground water details in the adjoining open well with site-specific Geo-coordinates.

The proponent submitted the documents on 13-11-2019.

- 3. The proposal was placed in the 106<sup>th</sup> meeting of SEAC held on 28<sup>th</sup>, 29<sup>th</sup> & 30<sup>th</sup> November 2019. The Committee decided to invite the proponent for presentation.
- 4. The proposal was placed in the 109<sup>th</sup> meeting of SEAC held on 31<sup>st</sup> & 01<sup>st</sup> February 2020. The Proponent was present. The Committee decided to recommend the issuance of the Extension of EC for a period of 3 months for a quantity of 8500 m<sup>3</sup> subject to the condition that the depth of mining shall not exceed 2 m from the ground level at any point of the mine.
- 5. The proposal was placed in the 103<sup>rd</sup> meeting of SEIAA held on 24<sup>th</sup>& 25<sup>th</sup> February 2020. Authority decided to extend the EC for 6 months as per the original terms and conditions in the EC already issued.
