## ORDER

Based on a recommendation of the then existed State Committee on Environmental Planning and Coordination, orders had been issued as per the G.O read as first paper requiring review and assessment of environmental implication of development projects and clearance by the Committee for all projects costing ₹ 10.00 lakhs and above. In the case of project costing less than ₹ 10.00 lakhs, environmental implication were required to be assessed by the department concerned based on the guidelines formulated by the Committee.

2. Now, comprehensive statutory measures have been introduced for imposing necessary restriction and prohibition on new projects or activities or expansion or modernization of existing projects or activities based on the potential environmental impacts, under sub-rule (3) of rule 5 of the Environment (Protection) Rules 1986 and in respect of matters not covered by the said notification, consultation with the Environment Department in Government had been made mandatory while considering proposals at Government level for administrative sanction vide the Government Orders

read as third to fifth papers. In view of the above, the Government Order read as first paper need not be kept live hereafter.

3. Government therefore order that the G.O read as first paper be rescinded, but without prejudice to the actions, if any, taken thereunder or under any judgment or order of any court based thereon, and the action, if any, that could be taken thereunder being taken as per the Environment (Protection) Act, Rules or Notifications thereunder.
