**ORDER**


Sri. Sadiq Ali, Moorkath House, Pathayakallu, Melmuri, Kadampuzha P.O., Malappuram, submitted an application read as paper 1<sup>st</sup> above, for the Environmental Clearance of Laterite Building Stone Quarry project, for an area of 0.0940 Ha at Block No. 137 in Survey No. 42/101 of Chuzhali Village, Thaliparamba Taluk, Kannur.

2. The SEAC observed that even after prior intimation, the Project Proponent was absent for the presentation in its 157<sup>th</sup> and 161<sup>st</sup> SEAC meetings. Also, vide email dated 13-03-2024 the Project Proponent requested to withdraw the application. Therefore, in the 161<sup>st</sup> SEAC meeting, the Committee recommended to allow the Project Proponent to withdraw the application.



3. The Authority, in its 141<sup>st</sup> meeting agreed to the recommendation of the SEAC and decided to reject the application at the risk and cost of the project proponent.

4. In the above circumstances, the application for Environmental Clearance read as 1<sup>st</sup> paper above, submitted by Sri. Sadiq Ali, Moorkath House Pathayakallu, Melmuri, Kadampuzha P.O., Malappuram, for an area of 0.0940 Ha at Block No. 137 in Survey No: 42/101 of Chuzhali Village, Thaliparamba Taluk, Kannur, is hereby **REJECTED**, for the reasons mentioned in Para (2) above. The concerned department shall take necessary actions, if any.
