- Removal of earth should be restricted to 2 m above to the ground water table at the site. (111)
- The excavation activity shall not alter the natural drainage pattern of the area. (iv)
- The burrowed/excavated pit shall be restored by the project proponent for useful (V) purpose(s) as specified in the application.
- Appropriate fencing all around the borrowed/excavated pit shall be made to prevent (vi) any mishap.
- Measures shall be taken to prevent dust emission by covering of burrowed/excavated (vii) earth during transportation.
- Safeguards shall be adopted against health risks on account of breeding of vectors in (viii) the water bodies created due to borrowing/excavation of earth.
- Workers / labourers shall be provided with facilities for drinking water and sanitation. (IX)
- A benn shall be left from the boundary of adjoining field having a width equal to at (x)least half the depth of proposed excavation.
- A minimum distance of 15 m from any civil structure shall be kept from the periphery of (xi)
- The Environmental Clearance shall be liable to be cancelled in any case of violation of (xii)
