Mohamed Sadiq V under the provisions of EIA Notification, 2006 and as amended thereof subject to compliance of EC conditions issued vide EC letter No. EC23B001KL133253 was issued dated 24.03.2023.
- 5. The SEIAA, Kerala hereby accorded the transfer of EC issued to Sri. Abdul Rasack. P. Pattakkal House, Vadakkangara Post, Mankada (via), Malappuram, for the Granite Building Stone Quarry project for an area 2.1509 Ha at Survey Nos. 95/9-3, 95/7-4 in Mankada Village, Perinthalmanna Taluk, Malappuram, in favour of Sri. Mohamed Sadiq. V, Vengassery, Vadakkekulamba, Vadakkangara P.O, Malappuram under the provisions of EIA Notification, 2006 and as amended thereof.
- 6. The Ministry / SEIAA, Kerala may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory. The Ministry reserves the right to stipulate additional conditions, if found necessary.
- 7. The Project Proponent is under obligation to implement commitments made in the Environment Management Plan, which forms part of the prior EC issued vide dated 24.03.2023.
