3. - 4. The above-mentioned ToR proposal has been considered by the State Expert Appraisal Committee (SEAC) in its 173th meeting held on 4th 6th of November 2024 and the State Environment Impact Assessment Authority (SEIAA) in its 151th meeting held on 30th 31st December, 2024. The minutes of the meeting and all the Application and documents submitted [(viz. Form-1 Part A, Part B, Part C)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.
- 5. The brief about project details, the process involved and other salient features of the project along with environmental settings, as submitted by the Project in Form-1 (Part A & B)/Pre-Feasibility Report presented during SEAC/SEIAA meeting are annexed to this ToR.
- 6. The SEAC, in its 173th meeting, based on information & clarifications provided by the project proponent and after detailed deliberations, recommended Standard ToR for Category 1(a) 'Mining of Minerals' under the provision of EIA Notification, 2006 and as amended thereof, subject to the stipulation of certain additional studies as detailed in Annexure (1).
- 7. The SEIAA examined the proposal in its 151th meeting in accordance with the Environment Impact Assessment (EIA) Notification, 2006 & further amendments thereto and upon accepting the recommendations of the State Expert Appraisal Committee, hereby decided to grant Standard ToR for Category 1(a) 'Mining of Minerals' with two site specific additional studies as recommended by the Expert Committee for the instant proposal of Sri. Eldhose K Varghese, M/s BE ONE Associates for the proposed Granite Building Stone Quarry project for an area of 3.8510 Ha at Re-Sy Nos: 46/1, 46/2, 46/3, 47, 48/1- 1, 48/1, 48/2-1 in Thalanadu Village, Meenachil Taluk, Kottayam under the provisions of EIA Notification, 2006 and as amended thereof.
- 8. Validity of the Terms of Reference will be as per the EIA Notification, 2006.
