Subject: Rejection of Environmental Clearance (EC) to the proposed Project under the EIA Notification 2006-and as amended thereof -regarding.

Sir/Madam,

This is in reference to your application submitted to the SEIAA, Kerala vide proposal number SIA/KL/MIN/508539/2025 for the reappraisal of Environmental Clearance issued from DEIAA, Malappuram for the Granite Building Stone Quarry Project under the provision of the EIA Notification 2006-and as amended thereof.

2. The particulars of the proposal are as below :

In view of the particulars given in the Para above, the project proposal interalia including Form-2, Approved Mining Plan, EMP, PFR, etc. were submitted to the Ministry for an appraisal by the State Environmental Impact Assessment Authority, Kerala under the provision of EIA notification 2006 and its subsequent amendments.

4. The above-mentioned proposal has been considered by the State Expert Appraisal Committee (SEAC) in its 180th meeting held during 25th February 2025, and the State Environment Impact Assessment Authority (SEIAA) in its 156th meeting held on 01st March, 2025. The minutes of the meeting and all the Application and documents submitted [(viz. Form-2, Mining Plan, EMP, PFR etc.)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.

5. The SEAC in its 180th meeting, examined the Reappraisal application and noticed that as per the Cluster certificate dated 23.11.2024, the following authorised quarries are located within 500m radius of the proposed site indicates cluster condition.

- a) Quarry of Sri. Sakariya Pullat for an area of 1.1995 Ha.
- b) Quarry of C.K Abdul Azeez for an area of 4.8240 Ha.
- c) Quarry of M/s Super sands for an area of 4.9072 Ha.

Therefore, there exists cluster condition, necessitating the conduct of EIA study and public consultation as per the EIA Notification 2006 for which the Proponent has to apply for ToR. In the circumstance, the Committee recommended rejection of the proposal.

6. SEIAA in its 156th meeting noted the decision of 180th meeting of SEAC and observed that as per the Scheme of Mining dated 11.03.2024, the project proponent has conducted excess mining of 99,650.5 MT from the lease area and 4,123.9 MT from the buffer area. Through illegal/over extraction of the resources, the project proponent violated the EC conditions also, which caused severe damage to the environment that necessitates action for violation as per the EP Act, 1986. Further, Project Proponent has not submitted as per the checklist of documents to be provided as per OM dated 28.04.2023 required for reappraisal DEIAA issued ECs. Hence the Authority decided to reject the Application due to the cluster situation and violation of environmental conditions.

7. In the above circumstances, the application for reappraisal of Environmental Clearance issued from DEIAA, Malappuram for the Granite Building Stone Quarry Project, submitted by Sri. E.K Shahul Hameed, E.K House, Kannamangalam West P.O, Via A.R Nagar Malappuram, for an area of 3.5426 Ha at Re Survey No. 1 in Kannamangalam Village, Thirurangadi Taluk, Malappuram is hereby **REJECTED**, for the reasons mentioned above.
