- 4. The above-mentioned proposal has been considered by the State Expert Appraisal Committee (SEAC) in its 180th meeting held on 25th February 2025, and the State Environment Impact Assessment Authority (SEIAA) in its 156th meeting held on 1st March, 2025. The minutes of the meeting and all the Application and documents submitted [(viz. Form-2, Mining Plan, EMP, PFR etc.)] are available on PARIVESH portal which can be accessed by scanning the QR Code above.
- 5. The SEAC, in its 180th meeting, noted that the Project Proponent has not submitted all the documents as per the checklist of OM dated 28.04.2024 for reappraisal including the cluster certificate. Therefore, the Committee is unable to reappraise the proposal and hence recommended rejection. The Authority in its 156th meeting accepted the recommendation of SEAC and decided to reject the application.
- 6. In the above circumstances, the application for reappraisal of Environmental Clearance issued from DEIAA, Thiruvananthapuram for the Granite Building Stone Quarry Project, submitted by Sri. Adarsh S. Babu, Sourav, Puthennada Nagar-10, Thekkevila P. O. Kollam- over an extent of 1.8504 Ha, at Re-Sy Nos. 114/4, 114/14, 114/16pt, 113/1-1, 113/1-3, 113/1-3-1, 113/2-1, 113/2-2, 113/15 & 113/3 in Nellanad village, Nedumangad Taluk, Thiruvananthapuram is hereby **REJECTED**, for the reasons mentioned above.
