## **ORDER**

Mr. P.K.Chacko, Managing Director of M/s Oceanus Estates India (P) Limited., vide the application received on 27-01-2013 has sought amendment in environmental clearance for a height of 72.8 m from the already allowed 60m issued by MoEF under the EIA Notification, 2006 for the construction of residential apartment complex "Oceanus Maple" at Sy. Nos. 208/6, 208/7, 208/8, 208/9, 208/10, 208/11, 208/12, 208/13, 208/14, 211/10, 212/13 and 212/17 at North Thrikkakara Village, Kalamassery Municipality, Kanayannur Taluk, Ernakulam District, Kerala by M/s Oceanus Estates India (P) Limited. No forest land is involved in the present project.

It is interalia, noted that Ministry of Environment and Forests has forwarded the proposal/request of M/s Oceanus Estates India (P) Limited for amendment of Environmental Clearance issued vide No.21-303/2008-IA.III dated 15.06.2010 for the construction of residential apartment complex "Oceanus Maple" at North Thrikkakara Village, Kalamassery Municipality, Kanayamnur Tahuk, Ernakulam District, Kerala. The Environmental Clearance was accorded with a height restriction of 60 m. on the plea of non-availability of sufficient five fighting facilities in the area. The Ministry has transferred the proposal to SEIAA Kerala since the matter relates to the request from the project proponent for amendment of EC granted earlier to Category B project and SEIAA Kerala is empowered to deal with the same as it is in place. In the meantime the project proponent has also provided requisite documents to SEIAA Kerala for processing their application for Environmental Clearance and the proposal was considered in the 12th SEAC meeting held on 2th February 2013, 17th meeting held on 6th and 7th July 20 13, 19th meeting held on 6th and 7th

January 2014 decided to recommend for initiating violation proceedings against the proponent an consider the same after the violation proceedings are taken and action taken received thereon 26<sup>th</sup> SEIAA meeting held on 24<sup>th</sup> January 2014 decided to is sue show cause notice to the proponent as to why violation proceedings shall not be initiated against them. 27<sup>th</sup> meeting of SEIAA held on 11<sup>th</sup> March 2014 considered the detailed explanation submitted by the proponent dt. 24.02.2014 in reply to the show cause notice issued on 12.02.2014. On examination, it is seen that the proponent has already obtained EC from MoEF and the constructions are in turns with building permit issued by LSGI read with 0.M. dt. 19<sup>th</sup> June 2013 and have not exceeded the built up area approved by MoEF. Hence it is decided to set aside the violation proceedings and it is approved for amendment of EC for a height of 72.80 m where all other conditions specified in the EC issued by MoEF shall continue. The project comes under the Category B, 8(a) of Schedule of EIA Notification 2006.

The SEIAA, after due consideration of the relevant documents and additional clarifications submitted by the project proponent, and in view of the recommendations of SEAC, has approved for issuance of Environmental Clearance for the project mentioned above for a height of 72.8 m at its 27<sup>th</sup> SEIAA meeting held on 11<sup>th</sup> March 2014. Accordingly, the State Level Environment Impact Assessment Authority (SEIAA) Kerala constituted by Govt. of India vide Notification No. S.O. 2484(E) dt.3-11-2011 of Ministry of Environment and Forests, Govt. of India vide Notification No. S.O. 546(E) dt.25.02.2014 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 466 dated 25-02-2014, hereby accord amendment to the Environmental Clearance No. 21-303/2008-IA.III dt. 15<sup>th</sup> June 2010 of MoEF, as per powers vested with it under the provisions of Environment Impact Assessment Notification – 2006 and its subsequent amendments, only to the extent that the construction can be made upto a height of 72.8m unless otherwise specified by Airports Authority of India provided all other conditions in the EC issued by MoEF including the built up area and the validity shall remain unaltered.

Compliance of the above conditions will be monitored by the Directorate of the Department of Environment and Climate Change, Government of Kerala or its agencies and also by the Regional Office of the Ministry of Environment and Forests, Government of India located at Bangalore. Necessary support for entry and inspection should be provided by the project proponent to the staff of the Directorate and Ministry for monitoring purposes. In case of non-compliance of conditions, noted, if any, the Director, Department of Environment and Climate Change shall report the matter to the District Collector concerned to take necessary action under Environment Protection Act 1986.
