ORDER

Environment Clearance vide paper read 2nd was accorded to Smt.Bohi, W/o. Diyu, Cherppanathu Veedu, Annanadu. P.O, Thrissur – 680 324, for the mining of Ordinary Earth in Sy.Nos.237/5, 243/1 in Kodassery Village, Chalakudy Taluk, Thrissur District, Kerala for an extent of 0.4047 Ha.

2. The Proponent vide paper 3rd cited requested to extend the Environmental Clearance for the removal of ordinary earth. In the 126th meeting of SEAC held on 11th to 13th April 2022, the Committee examined and discussed the proposal in detail and recommended to extend the EC for 1 year from the date of issuance of permit from

Mining & Geology Department subject to the following Specific Conditions in addition to the General Conditions.

1. *The excavation should be limited to 1 m bgl on the side of the pond and up to 1.5 m bgl on the northern part.*
2. *Production of consent letter from the concerned end user of the excavated soil.*
3. *Production of affidavit stating that the soil will not be used for filling wetlands.*
4. *The protocols required to be observed for any activities under the RoW of the High Tension Line should be complied with.*

3. **Authority in its 114th meeting held on 25th & 26th May & 01st June 2022, decided to extend the EC for 1 year for the extraction of balance quantity of Ordinary Earth as approved in the original EC (4000m³) from the date of issuance of permit from Mining & Geology Department subject to the following Specific Conditions in addition to the original EC conditions and General Conditions.**

1. *The excavation should be limited to 1 m BGL on the side of the pond and up to 1.5 m BGL on the northern part.*
2. *Production of Consent letter from the concerned end user of the excavated soil.*
3. *Production of Affidavit stating that the soil will not be used for filling wetlands.*
4. *The protocols required to be observed for any activities under the Right of Way of the High Tension Line should be complied with.*

4. In the circumstance, the extension of Environmental Clearance for 1 year for the extraction of balance quantity of Ordinary Earth as approved in the Original EC (4000 m³) from the date of issuance of permit from the Mining & Geology Department, under Notification S.O. No.1533 (E) dated 14.09.2006 read with O.M. of the Ministry of Environment & Forest, Government of India, is hereby accorded to Smt.Bohi, W/o. Diju, Cherppanathu Veedu, Annanadu. P.O, Thrissur – 680 324, for the mining of Ordinary Earth in Sy.No.237/5,243/1 in Kodassery Village, Chalakudy Taluk, Thrissur

District, Kerala for an area of 0.4047 Ha. The extension of Environmental Clearance is subject to the Specific Conditions mentioned in Para 3 above in addition to the Terms and Conditions mentioned in the original EC.
