<u>ORDER</u>

Mr. Gireeshkumar K.V., Kalliyath tiles, Thycattusserry P.O., Cherussery * 6803 Zekkerela, has applied for Environmental Clearance on 23.04.2014 in simplified format for removal of 717 m³ of brick earth from 0.2151 hectares of land in Sy. Nos. 71/1 and 71/3 at Parappookkara Village & Panchayath, Mukundapuram Taluk, Thrissur District, Kerala, since the earth is not fertile. The removed earth is for using in tiles factory owned by the proponent. The application has been duly examined and certified by Additional Tahsildar, Mukundapuram. Forest land is not involved in the project. It is interalia, noted that the project comes under Category B, Activity 1(a), (i) of Schedule of EIA Notification 2006.

The proposal has been appraised by the State Level Expert Appraisal Committee Kerala constituted by the competent authority, as per prescribed procedure in the lights of provisions under the EIA Notification 2006 and subsequent amendments, in its 29th meeting held on 2nd and 3rd May 2014. SEAC Kerala considering the application, documents and clarifications provided by the proponent in person, recommended environmental clearance to the project, under the usual conditions for mining of brick earth/ordinary earth stipulated in O.M. dt. 24.06.2013 of Ministry of Environment and Forests, for removal of brick earth on condition that the land should be retained as paddy land.

The SEIAA, after due consideration of the relevant documents and additional clarifications submitted by the project proponent, and in view of the recommendations of SEAC, approved for is suance of Environmental Clearance for the project mentioned above at its 30th meeting held on 9th May 2014. Further, the proponent has submitted the documents stipulated by SEIAA. Accordingly, the State Level Environment Impact Assessment Authority (SEIAA) Kerala constituted by Govt of India vide

Notification No. S.O. 2484(E) dt. 3-11-2011 of Ministry of Environment and Forests, Govt. of India. published as Gazette extraordinary No. 2074 on 3-11-2011 and further amended by Govt. of India vide Notification No. S.O. 546(E) dt.25.02.2014 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 466 dated 25-02-2014, hereby accordinates are Environmental Clearance to Mr. Gireeshkumar K.V., Kalliyath tiles, Thycattusserry P.O., Cherusserry — 680322, Kerala, under the usual conditions for mining of brick earth/ordinary earth stipulated in O.M. dt. 24.06.2013 of Ministry of Environment and Forests, for removal of brick earth on condition that the land should be retained as paddy land, as per powers vested with it under the provisions of Environment Impact Assessment Notification — 2006 and subsequent amendments and also under the provisions made in O.M. No. L-11011/47/2011-IA.II(M) dated 18th May 2012 of the Ministry of Environment and Forests, Government of India, and further subject to strict compliance of the following specific and General conditions:

- (i) The activity shall not involve blasting.
- (ii) The maximum depth of removal of earth should not go beyond 2 m from the general ground level of the site, which should be prominently marked before initiating the work.
- (iii) Removal of earth should be restricted to 2 m above to the ground water table at the site.
- (iv) The excavation activity shall not alter the natural drainage pattern of the area.
- (v) The borrowed/excavated pit shall be restored by the project proponent for useful purpose(s) as specified in the application.
- (vi) Appropriate fencing all around the borrowed/excavated pit shall be made to prevent any mishap.
- (vii) Measures shall be taken to prevent dust emission by covering of borrowed/excavated earth during transportation.
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors in the water bodies created due to borrowing/excavation of earth.
- (ix) Workers / labourers shall be provided with facilities for drinking water and sanitation.
- (x) A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
- (xi) A minimum distance of 15 m from any civil structure shall be kept from the periphery of the excavation area.
- (xii) The land should be retained as paddy land.
- (xiii) Brick earth not exceeding 717 m³ of brick earth should only be removed from an area of 0.2151 hectare comprised in Sy. Nos. 71/1 and 71/3.
- (xiv) The Environmental Clearance shall be liable to be cancelled in any ease of violation of above guidelines.

Compliance of the above conditions will be monitored by the Directorate of the Department of Environment and Climate Change, Government of Kerala or its agencies and also by the Regional Office of the Ministry of Environment and Forests, Government of India located at B angalore. Necessary support for entry and inspection should be provided by the project proponent to the staff of the Directorate and Ministry for monitoring purposes. In case of non-compliance of conditions, noted, if any, the Director, Department of Environment and Climate Change shall report the matter to the District Collector concerned to take necessary action under Environment Protection Act 1986.
