## **ORDER**

M/s Thomsun Realtors (P) Ltd, 96, 10th floor, Abad Nucleus Mall & office, NH-49, Maraud. P.O, Kochi- 682304 has been granted environmental clearance as per the reference 1<sup>st</sup> for construction of the Prestige Forum Mall consisting of residential apartments and retail shopping malls at Maradu Municipality, Maradu Village, Kanayanoor Taluk, Ernakulam District, in Sy. Nos. 138/1, 2, 3, 4, 5, 6, 9, 11, 12, 13, 14, 15, 16, 139/1, 3, 4, 140/2, 3, 4, 5, 141/11, 13, 14, 145/4, 6, 7, 8, 176/21, 179/1, 10, 11, 25, 26 with total built up area of 1,74,492 m<sup>2</sup>. Now due to the market conditions they have revised the plan and the built up area has been reduced to 1, 54,675.35 m2, by deducting 19,812.65 m<sup>2</sup>. The E. C holder has requested for revised Environmental Clearance with the reduced built up area. No changes have been proposed in the thresholds of the conditions in the environmental clearance issued.
