#### **ORDER**

Vide Order read 1st above, Environmental Clearance was issued to the Quarry Project of Sri. Basil Madappilly, Managing Partner, M/s.Vilamana Industries in Sy. Nos 2059/1, 2060, 2061, 2063 of Kuttichira Village & Survey Nos . 928, 929, 930, 931, 932/1, 932/2 of Kodassery Village, Chalakudy Taluk, Thrissur District, Kerala for a period of five years.

2. Vide Judgment read paper (2) above, the Hon'ble High Court disposed off the Writ Petition by directing the regulatory bodies concerned to call for additional recommendations from the appraisal committees after estimating the life of the project of the petitioner in respect of which EC had been issued, and there upon re-validate the EC granted to the petitioner.

- 3. In the 128<sup>th</sup> meeting of SEAC held on 23<sup>rd</sup> & 24<sup>th</sup> May 2022, the Committee verified the documents submitted by the proponent, which were found satisfactory. The Committee also discussed the field inspection report. The Committee recommended the revalidation of EC with a Project Life of 6.5 years from the date of the original EC i.e. 23.4 2016 excluding Covid extension subject to certain Specific Conditions.
- 4. The 115<sup>th</sup> SEIAA meeting held on 30<sup>th</sup> June 2022, discussed the item and noted the decisions of various SEAC meetings, the CCR received from RO, MoEF & CC and the FIR of the Sub-committee. The Authority decided to revalidate the EC with a project life of 6.5 years from the date of issuance of original EC, i.e. 23.04.2016 excluding the Covid extension as recommended by SEAC in its 128<sup>th</sup> meeting, i.e., 1.5 years from 22.04.2022 (after Covid Relaxation). The EC is subject to Terms and Conditions in the original EC in addition to the General Conditions and the following Additional Specific Conditions.
  - 1. Compensatory afforestation should be done with immediate effect to compensate for lack of vegetation in the buffer zone with rocky patches on Eastern and Western boundaries.
  - 2. The growth status of buffer plantations should be monitored and geo-tagged photographs should be incorporated in the compliance report.
  - 3. The garland drain, silt traps, siltation pond and outflow channel should be cleaned periodically and geotagged photographs as proof should be submitted along with the half yearly compliance report.
  - 4. The inadequacy of the provision of benches should be corrected with immediate effect.
  - 5. The outflow from the settling pond should be connected to the nearest natural drain with necessary silt traps and maintained it periodically.
  - 6. Measures incorporated in the CER should be implemented in total during the first two years and they should be operated and maintained during the remaining project period.

- 7. The EC given is liable to be cancelled for violation of any of the EC conditions and misrepresentation of facts.
- 5. In the circumstance, Environmental Clearance issued vide paper 1<sup>st</sup> above is hereby revalidated for 6.5 years from the date of issuance of original EC, i.e. 23.04.2016 excluding the Covid extension i.e., 1.5 years from 22.04.2022 (after Covid Relaxation). The revalidation of Environmental Clearance is accorded subject to Terms and Conditions in the original EC in addition to the General Conditions and the additional Specific Condition mentioned in Para 4 above. The Project Proponent shall ensure that no violation of EC conditions takes place during the revalidation period of EC.
- 6. The Half Yearly Compliance Report (HYCRs) with its contents, covering letter, compliance details and environmental monitoring data have to be uploaded in the PARIVESH portal and the website of the proponent. The compliance report with the name of the project, EC No and date, period of submission should be sent to the Regional Office of MoEF & CC by e-mail only at email ID <u>rosz.bng-mefcc@gov.in</u>. Hardcopy of HYCRs shall not be acceptable.
