4) The Committee entrusted the Chairman, SEAC to take up the matter of providing adequate logistic and financial support for the sub-committees constituted for field level appraisal in accordance with that in practice of SEAC of other states.

It was decided to have the next meeting of SEAC on 24th December 2019.
