The Authority considered the agenda for the 132nd meeting and took the following decisions.

Item 132.01. Order dated 11/09/2023 in Appeal No. 5/2022 (SZ) filed by Sri. Shaji A. K. (1193/EC2/2018/SEIAA)

Authority perused the judgment dated 11-09-2023 of Hon'ble National Greens Tribunal (SZ) on Appeal No.05 of 2022(SZ) & I.A. Nos.194 to 196 of 2022 (SZ) filed by Mr. Shaji A.K.,S/o. Kuryakose, Arakkal House, Perinkari PO, Kannur District against the Environmental Clearance issued to Landmark Trade Centre Project, Pantheerankavu, Kozhikode. Authority noted that a discussion was already held with Advocate General at Govt. level on the follow up action to be taken specially on para 53 (vi) and (vii) as they adversely effect the functioning of SEIAA. The Authority decided the following

- (1) To request the Govt. of Kerala to expedite the process of filing Writ Petition against the judgement of the Hon'ble National Greens Tribunal specially covering para 53 (vi) and 53 (vii) of the said judgement as they adversely affect the functioning of State Environment Impact Assessment Authority, Kerala.
- (2) To file Writ Petition against the said judgement by SEIAA also through it's Standing Counsel in the Hon'ble High Court of Kerala specially covering the para 53 (vi) and (vii) as they adversely effect the functioning of SEIAA in the given circumstances.

The SEIAA Secretariat shall provide all necessary details to the office of Advocate General and Standing Counsel on priority and coordinate the efforts so that the appeals are filed within a week's time. The Administrator to follow up the case and update the Member Secretary on regular basis.
