ORDER

Environmental Clearance was issued vide paper read 1st above, to the Laterite Building Stone Quarry Project of Sri.P. J. Jacob in Survey. No. 65, Anakkara Village, Pattambi Taluk, Palakkad, Kerala for a period of one year from the date of issuance of Permit from Department of Mining and Geology. Sri.P. J. Jacob submitted an application for the extension of Environmental Clearance vide reference 2nd cited.

2. In the 136th SEAC meeting, the Committee considered the application for extension of the EC No. 953/A2/2019/SEIAA dated 16.11.2020 for the mining of laterite building stone to the tune of 63764 MT with mine life of one year. The Committee examined the proposal and documents submitted. Based on discussions, the Committee decided to recommend extension of validity of EC for 2 years from the date of execution of the EC order subject to the Specific and General conditions issued in the original EC.

3. In the 123rd SEIAA, the Authority decided to extend the validity of EC for 2 years for the balance quantity as per approved Mining Plan from the date of execution of mine permit with the Mining & Geology Department subject to the specific and general conditions issued in the original EC.

4. In the above circumstances, extension of validity of Environmental Clearance for 2 years is hereby accorded for the Laterite Building Stone Quarry Project of Sri.P. J. Jacob in Survey. No. 65, Anakkara Village, Pattambi Taluk, Palakkad, Kerala subject to the strict compliance of the Specific and General conditions in the EC issued vide paper read 1st.

5. The Half Yearly Compliance Report (HYCRs) with name of the project, EC No. and date, the period of submission with its contents, compliance report and environmental monitoring data & covering letter have to be uploaded in the Parivesh Portal as O.M. F.No.IA3-22/1/2022-IA-III(E)-17264 dated 14.06.2022 and the website of the project proponent. Hardcopy of HYCRs shall not be acceptable.
