- The naximum depth of removal of earth should not go beyond 2 m from the (ii) general ground level of the site, which should be prominently marked before initiating the
- Removal of earth should be restricted to 2 m above to the ground water table at the site. (iii) (iv)
- The excavation activity shall not alter the natural drainage pattern of the area.
- The burrowed/encavated pit shall be restored by the project proponent for useful (\mathbb{V}) purpose(s) as specified in the application
- Appropriate fencing all around the borrowed/excavated pit shall be made to prevent (V_i)
- Measures shall be taken to prevent dust emission by covering of burrowed/excavated (vii) carth during transportation.
- Safeguards shall be adopted against health risks on account of breeding of vectors in (viii) the water bodies created due to borrowing/excavation of earth.
