ORDER

Sri. Jijesh Korothan, Sandhya Nivas, Olayikkara, Kottayam Malabar P.O., Kannur, submitted an application read as paper 1st above, for the Environmental Clearance of Laterite Building Stone Quarry project, for an area of 0.0971 Ha at Block No.91, Re-Survey No:46/4-1204-2 in Kalliyad Village, Iritty Taluk, Kannur.

2. In the 159th meeting, the SEAC observed that even after prior intimation, the Project Proponent was absent for the presentation in the 156th SEAC meeting. The Project Proponent was also absent in the 159th SEAC meeting and intimated withdrawal of the same application through e-mail. Therefore, the Committee decided to recommend to allow the Project Proponent to withdraw the application.

3. The Authority, in its 140th meeting agreed to the recommendation of the SEAC and decided to reject the application at the risk and cost of the Project Proponent.

4. In the above circumstances, the application for Environmental Clearance read as 1st paper above, submitted by Sri. Jijesh Korothan, Sandhya Nivas, Olayikkara, Kottayam Malabar P.O., Kannur, for an area of 0.0971 Ha at Block No. 91, Re-Survey No: 46/4-1204-2

in Kalliyad Village, Iritty Taluk, Kannur, is hereby **REJECTED**, for the reasons mentioned in Para (2) above. The concerned department shall take necessary actions, if any.
