#### ORDER

The Authorized signatory of M/s Choice Constructions, vide letter no. CC/STAT/001 dated 21-03-2012 has sought environmental clearance under the EIA Notification, 2006 for the construction of a Residential Project 'CHOICE PARADISE' at Village Nadama, Taluk Kanayannur, Thripunithura Municipality, District Ernakulam, Kerala. The proposal has been appraised by the State Level Expert Appraisal Committee Kerala constituted by the competent authority, as per prescribed procedure in the lights of provisions under the EIA Notification 2006, in its 6<sup>th</sup> meeting held on 4<sup>th</sup> August, 2012 AND on the basis of the supporting documents enclosed with the application viz., the Form -1 & 1A, Conceptual Plan and the additional clarifications furnished in response to the observations, the SEAC Kerala recommended environmental clearance to the project.

It is interalia, noted that the project comes under the Category B, 8(a) of Schedule of EIA Notification 2006. It involves the construction of a Residential Project 'CHOICE PARADISE' at Village Nadama, Taluk Kanayannur, Thripunithura Municipality, District Emakulam, Kerala. facilities proposed for the residential project are 144 residential units with club house and swimming pool, etc. The total built-up area is of 29,692 m<sup>2</sup>. The total domestic water requirement for the proposed project is 105.44 KL/day. The waste water generated from the proposed Residential Project will be treated in a STP of capacity of about 115 KL/day. Solid waste of about 288 kg/day would be generated from the proposed project. Power requirement is 1630 KVA. Total cost of the project is ₹ 40 crores.

The SEIAA, after due consideration of the relevant documents and additional clarifications submitted by the project proponent, and in view of the recommendations of SEAC, approved for issuance of Environmental Clearance for the project mentioned above at its 7<sup>th</sup> meeting. Accordingly, the State Level Environment Impact Assessment Authority (SEIAA) Kerala constituted by Govt. of India vide Notification No. S.O. 2484(E) dt.3-11-2011 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 2074 on 3-11-2011, hereby accord Environmental Clearance for the above project as per powers vested with it under the provisions of Environment Impact

Assessment Notification 2000 and its subsequent amendments, subject to strict compliance of following specialise conclinuis, and also the general conditions contained in the Annexure, which shall also form a prattel this document.

- 1. The dults and mock evacuation drills shall be conducted at least once in three months. Participation of maximum number of inhabitants shall be ensured in the mock evacuation drills. The students of the nearby so had may also be made aware of the fire fighting mechanisms provided in the building.

## STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY KERALA

#### GENERAL CONDITIONS

- (i) Rain water harvesting to collect and utilize the entire water falling in land area should be provided.
- (ii) Environment Monitoring Cell should be formed and made functional.
- (iii) Suitable avenue trees should be planted along either side of the tarred road and open parking areas, if any.
- (iv) The project may incorporate devices for solar energy generation and utilization wherever possible.
- (v) In the case of any change(s) in the scope of the project, the project would require a fresh appraisal by this Authority.
- (vi) The Authority reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environmental (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- (vii) All other statutory clearances shall be obtained, as applicable, by project proponents from the respective competent authorities.
- (viii) The stipulations by Statutory Authorities under different Acts and Notifications should be complied with, including the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006.
- (ix) The project proponent should advertise in at least two local newspapers widely circulated in the region, one of which shall be in the vernacular language informing that the project has been accorded Environmental Clearance and copies of clearance letters are available with the Department of Environment and Climate Change, Govt. of Kerala and may also be seen on the website of the Authority at www.seiaakerala.org. The advertisement should be made within 10 days from the date of receipt of the Clearance letter and a copy of the same should be forwarded to the office of this Authority as confirmation.
  - (x) A copy of the clearance letter shall be sent by the proponent to concerned Grama Panchayat/ District Panchayat/ Municipality/Corporation/Urban Local Body and also to the Local NGO, if any, from whom suggestions / representations, if any, were received while processing the proposal. The clearance letter shall also be put on the website of the company by the proponent.
  - (xi) The proponent shall submit six monthly reports on the status of compliance of the stipulated EC conditions including results of monitored data (both in hard copies as well as by e-mail) and upload the status of compliance of the stipulated EC conditions, including results of monitored data

on their website and shall update the same periodically. It shall simultaneously be sent to it respective Regional Office of MoEF, Govt. of India and also to the Directorate of Environment and Climate Change, Govt. of Kerala.

(xii) The proponent should provide affidavit that all the conditions stipulated in the EC shall be scrupulously followed.
