- Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).
- The KML/Shape files should be emailed to mentioned at para No. 7 below at least 5 days prior to the meeting.**
- The above all documents are required to be forwarded to the Chairman/Members of the Expert Appraisal Committee along with soft copy.

- All the documents including the hard copy of the presentation material should be legible and printed on both sides on ordinary paper. **In case the members of the**

**Expert Appraisal Committee do not receive the proposals/documents before the meeting, the Committee will not consider the project.**
