<u>ORDER</u>

Mr. P.K.Mohamed Ashraf, Managing Partner, M/s Hi-Tech Metals, Naduvakkadu, Oorakam – Melmuri. P.O., Malappuram District, Kerala – 676519, has been granted Environmental Clearance for the proposed quarry project in Sy. Nos. 1/1, 278/Pt and 165/2, at Oorakam, Morayur and Nediyiruppu Village & Panchayat and Tirurangadi & Eranad Taluks, Malappuram district, Kerala, vide order read 1st above.

The proponent submitted a representation vide ref (2) above to SEIAA to extend the validity period of EC, as the validity is to expire on 22.05.2018. The proponent had also submitted the mining plan dated 27.07.2017 for the proposed quarry project in Sy. Nos. 1/I, 278/Pt and 165/2, at Village & Panchayath: Oorakam, Morayur and Nediyiruppu, Taluk: Tirurangadi & Eranad, Malappuram district, Kerala.

The proposal was placed in the 81st meeting of SEIAA held on 08.03.2018 and the Authority decided to extent the validity of EC subject to the production of a certificate from a Geologist indicating the life of mine. The proponent has submitted a letter from Geologist, Malappuram vide ref (4) above stating that the life of mine as per the mining plan is 16 years.

In the above circumstances, the period of validity of the Environmental Clearance issued vide proceedings read 1st above, for the proposed quarry project in Sy. Nos. 1/1, 278/Pt and 165/2, at Oorakam, Morayur and Nediyiruppu Village & Panchayath, Tirurangadi & Eranad Taluks, Malappuram district, Kerala by Mr. P.K.Mohamed Ashraf, Managing Partner,M/s Hi-Tech Metals is extended for a further period of 5 years, subject to all terms and conditions stipulated in the Environmental Clearance order, issued earlier.
