Environment Department- Levying One time Processing Charge on applications for Environmental Clearance by the State Environment Impact Assessment Authority - Sanctioned - Orders issued.

ORDER

The Director, Environment & Climate Change as per the letters read above has proposed to levy One time Processing Charge on applications for Environment Clearance by the State Environment Impact Assessment Authority (SEIAA).

Government have examined the proposal in detail and are pleased to accord sanction to levy One time Processing Charge on the applications for Environment Clearance by the SEIAA as per the rates fixed and stated as below:

1. Applications for Environmental Clearance other than for mining activities : Rs. 2 lakh
2. Applications for Environmental Clearance for mining activities -
 - (a) Mining area not less than 10 ha - Rs. 2.50 Lakh
 - (b) Mining area below 10 ha but not less than 5 ha - Rs. 2.00 Lakh
 - (c) Mining area below 5 ha but not less than 1 ha - Rs. 1.00 Lakh
 - (d) Mining area below 1 ha - Rs. 0.75 Lakh

The Departments under the Government of India and Government of Kerala are exempted from payment of processing charges.

The Public Sector Undertakings, Boards, Corporations, etc. shall pay the processing charge at the time of submitting their applications as per the rates fixed as above.

Seperate order will be issued specifying the Head of Account in which the processing charge is to be remitted.
