ORDER

Environment Clearance has been issued for the quarry project in Sy.Nos. 81 pt, 82 pt, 83 pt and 84 pt at Cherpulassery Village and Panchayat, Ottappalam Taluk, Palakkad District for an area of 7.1056 hectares to Sri.Jassin Joseph, Managing Partner, M/s Hywel Granites vide EC No.124/SEIAA/KL/2334/2013 dated 22.11.2013.Later Sri.Jassin Joseph handed over this quarry to Sri.M.A.Ashraf and on request, SEIAA transferred the EC to Sri.M.A.Ashraf Managing Partner, M/s Ferro Granites LLP and Infra Granites LLP, Karad

P.O, Kondotty, Malappuram as per the proceedings read as 2nd paper above. Shri.M.A.Ashraf, Managing Partner has now requested to extend the validity of the EC granted which is to expire on 30.10.2018.

2. The proposal was placed in the 83rd meeting of SEIAA held on 22nd October 2018. SEIAA decided to hold another meeting on 26.10.2018 with the proponent and RQP for collecting some technical details.
3. The 84th meeting of SEIAA held on 26.10.2018 decided to refer the matter to SEAC for a report. Accordingly, the proposal was placed in the 89th meeting of SEAC and Committee entrusted Dr.P.S.Easa & Shri.K.Krishna Panicker for site visit and report.
4. The proposal was placed again in the 90th meeting of SEAC held on 04.01.2019 and deferred the item for next meeting due to constrain of time.
5. Later, the proposal was placed in the 91st meeting of SEAC held on 14th January, 2019. The Committee approved the Sub-Committee report and the observations of the Sub-Committee and decided to obtain some additional details based on the report of Sub Committee as follows.
 1. The Biological Environment part has to be rewritten after a proper assessment of the flora and fauna of the area. This part may be resubmitted and considered before granting Environmental Clearance.
 2. The CSR part needs to be reworked based on need assessment.
6. The proponent has submitted the above mentioned details on 02.02.2019 and the proposal was placed again in the 93rd SEAC meeting held on 21st February, 2019. But, the Committee deferred the item for next meeting.
7. The proposal was again placed in the 94th meeting of SEAC held on 12th & 13th March 2019 and Committee after examination decided to recommend for EC subject to general conditions and specific condition that the depth of the excavation should not go further beyond the floor of the adjacent streams.
8. The proposal was placed in the 90th Meeting of SEIAA held on 29th March, 2019 and Authority decided to issue EC for an area of 3.0757 ha as per the revised Mining Plan subject to general conditions and specific conditions that

- 1) The depth of the excavation should not go further beyond the floor of the adjacent streams.
- 2) Mining shall be carried out as per the rules & regulations of approved Mining Plan.
- 3) CER activities are to be carried out as per local requirement in consultation with District Collector as per OM No.22-65/2017-IA.III dated 1st May 2018 of MoEF & CC.

9. In the above circumstances, extension of validity of Environmental Clearance for 5 years from 30.10.2018 is hereby accorded for the quarry project in Survey Nos. 81 pt, 82 pt, 83 pt and 84 pt at Cherpulassery Village and Panchayath, Ottappalam Taluk, Palakkad District, Kerala owned by Infra Granites subject to the strict compliance of the conditions in the EC already issued and as per the following specific conditions

- 1) The depth of the excavation should not go further beyond the floor of the adjacent streams.
- 2) Mining shall be carried out as per the rules & regulations of approved Mining Plan.
- 3) CER activities are to be carried out as per local requirement in consultation with District Collector as per OM No.22-65/2017-IA.III dated 1st May 2018 of MoEF & CC.
