ENVIRONMENTAL CLEARANCE NO. 08/2019

Sri. Chandra Bose.J., Managing Director, Metal Industries Limited, Shornur, Palakkad- 679122, has submitted an application for EC in SEIAA for removal of ordinary earth from the land in Sy.No.3/3 B at Shoranur-1 Village, Ottapalam Taluk, Palakkad District, Kerala for an area of 0.2070 Hectare, as per paper read as 2nd paper above. The quantity proposed to be removed is 14,308 m³.

- 2. The proposal was placed in the 94th meeting of SEAC held on 12th & 13th March 2019. The Committee decided to recommend the proposal for issuance of EC, subject to the condition that the earth material shall be used in proponent's own land.
- 3. The proposal was then placed in the 90th meeting of SEIAA held on 28th March 2019. Authority decided to issue EC subject to general conditions and the condition

that the earth material shall be used in proponent's own land without affecting the environmental stability of the region.

4. Environmental Clearance under notification S.O. No.1533 (E) dated 26.09.2006 read with read as first paper, is hereby accorded to Sri. Chandra Bose.J., Managing Director, Metal Industries Limited, Shornur, Palakkad- 679122, for removal of 14,308 m³ of ordinary earth from 0.2070 Hectare of land in in Sy.No.3/3 B at Shoraur-1 Village, Ottapalam Taluk, Palakkad District, Kerala to open up a petrol pump at Shornur is subject to strict compliance of the following general conditions and the specific condition that the earth material shall be used in proponent's own land without affecting the environmental stability of the region.

General conditions

- (i) The activity shall not involve blasting.
- (ii) The maximum depth of removal of earth should not go beyond 2m from the general ground level of the site. The level should be prominently marked before initiating the work.
- (iii) Removal of earth should be restricted to 2m above to the ground water table at the site.
- (iv) The excavation activity shall not alter the natural drainage pattern of the area.
- (v) The burrowed/excavated pit shall be restored by the project proponent for useful purpose(s) as specified in the application.
- (vi) Appropriate fencing all around the burrowed/excavated pit shall be made to prevent any mishap.
- (vii) Measures shall be taken to prevent dust emission by covering of burrowed/excavated earth during transportation.
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors in the water bodies created due to burrowing/excavation of earth.
- (ix) Workers/labourers shall be provided with facilities for drinking water and sanitation.
- (x) A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
- (xi) A minimum distance of 15 m from any civil structure shall be kept from the periphery of the excavation area.
- (xii) The quantity of O.E being excavated from each site is to be deposited at each work site, shall be fixed.
- (xiii) The Environmental Clearance shall be liable to be cancelled in any case of violation of any of the above conditions.

Violation of any of above general conditions as applicable to the particular case will entail cancellation of the EC, in addition to legal action under the provisions of the Environment (Protection) Act, 1986 and Notification No.S.O.637 (E) dated 28.02.2014 of the MoEF, Govt. of India. Non-compliance if any shall be reported to the District Collector, Palakkad by the State Environment Impact assessment Authority
