ENVIRONMENTAL CLEARANCE NO.58/O.E/2019

Sri.V.Anilkumar,Secretary,Ponmeri Service Sahakarana Bank Ltd
No.D2677, P.O.Ponmeriparambil-673542 has submitted an application for
Environmental Clearance in SEIAA for mining of ordinary earth from the land at Sy.
No. 32/14 of Ayancheri Village,Vadakara Taluk,Kozhikode District. The proposal is
for mining of ordinary earth from an area of 0.0256 ha of land for removing 603.75 m³.

The proposal was placed in the 101st meeting of SEAC held on 01st & 02nd August 2019. The Committee decided to recommend for EC subject to the general conditions

The proposal was placed in the 97th meeting of SEIAA held on 24th September 2019. Authority decided to issue EC for 6 months for a quantity of 600 m³ subject to following specific condition in addition to general conditions.

- *The proponent shall carry out quarrying as per the approved Mining Plan and the proponent should strictly follow the Kerala Minor Mineral Concession Rules 2015 and amendments thereby.*

In the circumstances the Authority is pleased to accord Environmental Clearance under Notification S.O. No.1533 (E) dated 26.09.2006 read with O.M. as first paper above of the Ministry of Environment & Forest, Government of India, to Sri.V.Anilkumar, Secretary, Ponmeri Service Sahakarana Bank Ltd No.D 2677, P.O.Ponmeriparambil-673542 for 6 months for a quantity of 600 m³ of ordinary earth from the land in Sy. No.32/14 of Ayancheri Village, Vadakara Taluk, Kozhikode District subject to the above specific conditions and the following general conditions.


General conditions

- (i) The activity shall not involve blasting.
- (ii) The maximum depth of removal of earth should not go beyond 2m from the general ground level of the site (lithomark). The level should be prominently marked before initiating the work.
- (iii) Removal of earth should be restricted to 2m above to the ground water table at the site.
- (iv) The excavation activity shall not alter the natural drainage pattern of the area.
- (v) The burrowed/excavated pit shall be restored by the project proponent for useful purpose(s) as specified in the application.
- (vi) Appropriate fencing all around the burrowed/excavated pit shall be made to prevent any mishap.
- (vii) Measures shall be taken to prevent dust emission by covering of burrowed/excavated earth during transportation.
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors

in the water bodies created due to burrowing/excavation of earth.

- (ix) Workers/labourers shall be provided with facilities for drinking water and sanitation.
- (x) A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
- (xi) A minimum distance of 15 m from any civil structure shall be kept from the periphery of the excavation area.
- (xii) The quantity of O.E being excavated from each site is to be deposited at each work site shall be fixed.
- (xiii) The Environmental Clearance shall be liable to be cancelled in any case of violation of any of the above conditions.

Violation of any of above specific and general conditions as applicable to the particular case will entail cancellation of the Environmental Clearance, in addition to legal action under the provisions of the Environment (Protection) Act, 1986. Non-compliance if any shall be reported to the District Collector, Kozhikode by the State Environment Impact assessment Authority
