The 116th meeting of the SEAC KERALA was held online during 2nd, 3rd & 7th December, 2020 observing all the lockdown protocols stipulated by the Government. As per the applications, EIA reports and the village map displayed by the proponent during the presentation, the project area includes land parcel that is part of both the proposal and the project areas exhibit common boundary. Therefore, both the applications are for obtaining EC for areas in contiguity. The proponent submitted that the actual mining would be taking place in smaller pockets of land which is not in contiguity or share common boundaries. In order to prove this, the proponent has agreed to submit the survey sketch of the mining area certified by the concerned Village Officer and also a sworn affidavit stating that mining will take place only from the two areas which are not in contiguity.
