<u>ORDER</u>

Mr. Niyas Vattakandi Soopy, Authorized Signatory, M/s Areacode Granites Private Limited, vide his application received on 29-06-2013, has sought Environmental Clearance under EIA Notification, 2006 for the proposed quarry project in Sy. Nos. 213 pt., 214 pt. and 215 pt. at Kavanoor Village and Panchayath, Eranad Taluk, Malappuram district, Kerala for an area of 4.2695 hectares. The land use classification of the project site as per revenue records is private land. Out of the total 11.336 hectares of land owned by the proponent, the lease area consists of 4,2695 hectares which is private land and present land use is quarrying activities. The quarry site is possessed in the name of M/s Areacode Granites Private Limited. This is an existing mine over about 0.34 hectare of pit area. The quarry is in operation since December 2010, when EC was not required for areas below 5 ha. The current proposal is for the existing quarry and hence no alternate site was examined as the project is mineral specific. Forest land is not involved in the project. It is interalia, noted that the project comes under Category B2, Activity 1(a), (i) of Schedule of EIA Notification 2006. The proposed project site falls within 11°12'56.96" N to 11°13'3.91"N and 76°05'03.01" E to 76°05'10.60" E. The proposed project is for quarrying of 2,55,000 MTA of building stone from an area of 4,2695 hectares of land. The expected life of mine will be 11 years.

The proposal has been appraised by the State Level Expert Appraisal Committee Kerala constituted by the competent authority, as per prescribed procedure in the lights of provisions under the EIA Notification 2006 and subsequent amendments, in its 182 th meeting held on 3rd August 2013 and 21st meeting held on 4th November 2013 AND on the basis of the supporting documents enclosed with the

Application viz., the Form — 1, questionnaire for mining project, pre-feasibility report, Environmental Clarifications furnished in response to the observations, the SEA.

Kerala recommended environmental Clearance to the project.

Part of the proposed land is already under mining and there is no top soil in those areas. The remaining land is having top soil and overburden with average thickness of 2.5 m in pit-1 2.0 m in pit-2 and 1.0 m in pit-3. The proposed project activity involves about 95 % of the pit area for exploring building stone. At the end of life of mine, excavated pit will be partially backfilled, reclaimed and rehabilitated by plantation and partially will be used as a water reservoir. The proposed project does not involve any underground mining activities. The mining will be done by open cast semi-mechanized method of mining. The banch height inderview research is San The replaintenant mining the being done from 75 m to 35 m MSL in conceptual phase. About 15,062 m³ of top soil will be generated from the proposed pit, which will be properly stacked within their own property but outside the proposed mine lease area and will be utilized for plantation over the reclaimed areas. About 7531 m³ of byerburden will be generated from the proposed pit, which will be properly stacked within their own property but outside the proposed mine lease area and will be utilized as a soil base for plantation over the reclaimed areas. The sewage of 1.5 KLD generated from the mine office will be diverted to the septic tank followed by soak pit. The municipal solid waste generated from the labour quarter will be suitably disposed. The sludge generated from the septic tank will be dried and used as manure in blantation. The daily water requirement of 6 KLD will be met from existing open well /storm water collection pond. The total power requirement of 75 kW will be drawn from diesel engine. There will be fugitive emissions generated during material handling, transportation, loading, unloading, etc. that are proposed to be managed by regular water sprinkling on haul road, green belt development, avoiding overloading of vehicles, maintaining the speed of vehicles within prescribed limits and covering the load with tarpaulin sheets. Plantation with shrubs, herbs and trees will be done as part of eco-restoration work. Anticipating 50% growth rate, at the end of life of mine, about 3,500 trees will be grown in total area. Chaliyar River is at a distance of 101 m N from the lease boundary. High Tension power line, Low tension power line and Defence Establishment (MSP Camp) is located at a distance of 4 km W from the project site. The nearest human settlement is 103 m NE of the project site. The quarry is interlinked with a crusher unit located within the complex. As stated by the proponent, there is no litigation pending against the lease area / applicant of the lease area in any court of law. The total cost of the project is Rs. 1.85 Crores.

The SEIAA considered the proposal in its 24th meeting held on 22nd November 2013 and 29th receting held on 9th April 2013. The SEIAA, after due consideration of the relevant documents and additional clarifications submitted by the project proponent and in view of the recommendations of

MAC, approved for issuance of Environmental Clearance for the project mentioned above at its 29th meeting held on 9th April 2014. Accordingly, the State Level Environment Impact Assessment Authority (SEIAA) Kerala constituted by Govt. of India vide Notification No. S.0. 2484 (E) dt. 3-11-2011 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 2074 on 3-11-2011 and further amended by Govt. of India vide Notification No. S.0. 546(E) dt.25.02.2014 of Ministry of Environment and Forests, Govt. of India, published as Gazette extraordinary No. 466 dated 25-02-2014, hereby accord necessary Environmental Clearance for the quarry project in Sy. Nos. 213 pt., 214 pt. and 215 pt. at Kavanoor Village and Panchayath, Eranad Taluk, Malappuran district, Kerala by M/s Areacode Granites Private Limited as perpowers vested with it under the provisions of Environment Impact. Assessment Notification 2006 and subsequent meading to the Ministry of Environment and Forests, Government of India, and further subject to strict compliance of the following specific conditions, and the general conditions contained in the Annexure, which shall also form a part of this document:

- 1. New haulage roads should be taken and top to bottom approach to be followed for further mining.
- 100 m should be left from the Chaliyar river edge without conducting quarrying activities.
- 3. The existing level of the quarry should not be deepened further.
- 4. The workers should be provided with reasonable dwelling units and proper sanitation facilities including supply of safe drinking water.
- 5. The crusher unit should be installed with all the conditions stipulated by KSPCB.

Compliance of the above conditions will be monitored by the Directorate of the Department of Environment and Climate Change, Government of Kerala or its agencies and also by the Regional Office of the Ministry of Environment and Forests, Government of India located at Bangalore. Necessary support for entry and inspection should be provided by the project proponent to the staff of the Directorate and Ministry for monitoring purposes. In case of non-compliance of conditions, noted, if any, the Director, Department of Environment and Climate Change shall report the matter to the District Collector concerned to take necessary action under Environment Protection Act 1986.

STATE ENVIRONMENT IMPACT ASSESSIVE AUTHORITY KERALA GENERAL CONDITIONS (Formining projects)

- (i) Rain Water Harvesting capacity should be installed as per the prevailing provisions of KMBR / KPBR, unless otherwise specified elsewhere.
- (ii) Environment Monitoring Cell as agreed under the affidavit filed by the proponent should be formed and made functional.
- (iii) Suitable avenue trees should be planted along either side of the tarred road and open parking areas, if any, inclusive of approach road and internal roads.
- (iv) The project shall incorporate devices for solar energy generation and utilization wherever possible.
- (v) Sprinklers shall be installed and used in the project site to contain dust emissions.
- (vi) Eco-restoration including the mine closure plan shall be done at the own cost of the project proponent.
- (vii) At least 10 percent out of the total excavated pit area should be retained as water storage areas and the remaining area should be reclaimed with stacked dumpings and overburden and planted with indigenous plant species that are eco-friendly.
- viii) Corporate Social Responsibility (CSR) agreed upon by the proponent should be implemented in tune with the conditions specified in the Companies Act, 2013.
- (ix) Barbed metal wire fencing around the mining area shall be provided with a height of not less than 5 ft so that falling of animals/human beings/dumping of garbages etc. does not happen.
- (x) Warning alarms indicating the time of blasting (to be done at specific timings) has to be arranged as per stipulations of Explosive Department.
- (xi) Control measures on noise and vibration prescribed by KSPCB should be implemented.
- (xii) Quarrying activities should be limited to day time as per KSPCB guidelines.
- (xiii) Blasting should be done in a controlled manner as specified by the regulations of Explosives Department or any other concerned agency.
- (xiv) A licensed person should supervise/ control the blasting operations.
- (xv) Access roads to the quarry shall be tarred to contain dust emissions that may arise during transportation of materials.
- (xvi) Overburden materials should be managed within the site and the old quarries, if any, should be reclaimed and restored.
- (xvii) Height of benches should not exceed 5 m and width should not be less than 5 m.
- (xviii) Mats to reduce fly rock blast to a maximum of 10 PPV should be provided.
- (xix) Mining death should not exceed beyond 40 m, unless otherwise specified or not below the level of nearest stream bed, whichever is less.
 - (xx) No mining operations should be carried out at places having a slope greater than 45.
- (xxi) Acoustic enclosures should have been provided to reduce sound amplifications in addition to the provisions of green belt and hollow brick envelop for crushers so that the noise level is kept within prescribed standards given by CPCB/KSPCB.
- (xxii) The workers on the site should be provided with the required protective equipment such as ear muffs, helmet, etc.
- (xxiii) Garland drains with clarifiers to be provided in the lower slopes around the core area to channelize storm water.
- (xxiv) The transportation of minerals should be done in covered trucks to contain dust emissions.
 - (xxv) The proponent should plant trees at least 5 times of the loss that has been occurred while clearing the land for the project.

- (xxvi) Dispositof spent oil from diesel emgines should be a specified underelevant Rules/Regulations.
- (xxvii) Explosives should be stored in magazines in isolatelplace specified and approved by the Equitives Department.
- (xxviii) Norms of Kerala State Pollution Control Board should be adhered to regarding distance offeria of residences, roads, rivers and worship places.
 - (xxix) 200 mbiffer distance should be maintained from forest boundaries.
 - (XXX) Consent from Kerala State Pollution Control Boardunder Water and Air Act(s) should have been obtained before initiating activity.
 - (xxxi) All other statutory clearances should have been obtained, as applicable, by project proponents from the respective competent authorities including that for blasting and storage of explosives.
 - (xxxii) In the case of any change(s) in the scope of the project, the project would require a fresh appraisal by this Authority.
- (xxxiii) The Authority reserves the right to add additional safeguard measures subsequently, if found necessary, and to take action including revoking of the environment clearance under the provisions of the Environment (Protection) Act, 1986, to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner.
- (xxxiv) The stipulations by Statutory Authorities under different Acts and Notifications should be complied with, including the provisions of Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and control of Pollution) act 1981, the Environment (Protection) Act, 1986, the Public Liability (Insurance) Act, 1991 and EIA Notification, 2006.
- The project proponent should advertise in at least two local newspapers widely circulated in the region, one of which (both the advertisement and the newspaper) shall be in the vernacular language informing that the project has been accorded Environmental Clearance and copies of clearance letters are available with the Department of Environment and Climate Change, Govt. of Kerala and may also be seen on the website of the Authority at www.seiaakerala.org. The advertisement should be made within 10 days from the date of receipt of the Clearance letter and a copy of the same signed in all pages should be forwarded to the office of this Authority as confirmation.
- (xxxvi) A copy of the clearance letter shall be sent by the proponent to concerned Grama Panchayat/ District Panchayat/ Municipality/Corporation/Urban Local Body and also to the Local NGO, if any, from whom suggestions / representations, if any, were received while processing the proposal. The Environmental Clearance shall also be put on the website of the company by the proponent.
- The proponent shall submit half yearly reports on the status of compliance of the stipulated EC conditions including results of monitored data (both in hard copies as well as by e-mail) and upload the status of compliance of the stipulated EC conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the respective Regional Office of MoEF, Govt. of India and also to the Directorate of Environment and Climate Change, Govt. of Kerala.
- (xxxviii) The details of Environmental Clearance should be prominently displayed in a metallic board of 3 ft x 3 ft with green background and yellow letters of Tippes New Roman font of size of not less than 40.
- (XXXIX) The proponent should provide notarized affidavit (*indicating the number and date of Environmental Clearance proceedings*) that all the conditions stipulated in the EC shall be scrupulously followed.
