- (i) The activity shall not involve blasting.
- (ii) The maximum depth of removal of earth should not so beyond 2 no from the general gound level of the site, which should be promisently market before initiating the work.
- (iii) Renoval of earth should be restricted to 2 m above to the ground water table at the site.
- (iv) The excavation activity shall not after the natural frainage pattern of the area
- (v) The burrowed/excavated pit shall be restored by the project proportion for useful purpose(s) as specified in the application.
- (vi) Appropriate fencing all around the borrowed/excavated pit shall be made to prevent any mishap.
- (vii) Measures shall be taken to prevent dust emission by covering of burrowed/excavated earth during transportation.
- (viii) Safeguards shall be adopted against health risks on account of breeding of vectors in the water bodies created due to borrowing/excavation of earth.
- (ix) Workers / labourers shall be provided with facilities for drinking water and sanitation.
- (x) A berm shall be left from the boundary of adjoining field having a width equal to at least half the depth of proposed excavation.
- (xi) A minimum distance of 15 m from any civil structure shall be kept from the periphery of the excavation area.
- (xii) The Environmental Clearance shell be liable to be cancelled in any case of violation of above conditions.
